4 Chairmans Report

Mr John Powell, Chairman, thanked all the members for an extremely good open day season and for their invaluable support to the Museum.

Mr Powell advised members that, sadly, four long serving members have passed away this year:

Ruby Sharp who ran the pottery for many years;

Roy Smith who operated the bookbinding shop;

Nigel Thompson who was involved in much of the building work in the early days and of course his tractor, the sound of which has been a background to many open days;

Norman Groom – a past President, Norman was an integral and important part of the museum for many years. Members were advised that his ashes were being scattered, at his request, at the museum on Sunday 22 October at 3.00pm and that anyone wishing to pay their respects was welcome to attend.

5 Treasurers Report and Approval of Accounts for the year ending 31 March 2023

Mr John Youngs, Treasurer, reported on last year's accounts (summary previously circulated). He advised that open day takings were the best ever, at £33,190 (before catering and specific open day costs) and that all other income was similar to previous years.

The only exceptional item in the year was the repair of one of the main trusses in the barn roof at a cost of £3840. All other costs were as planned or expected.

After all costs a surplus (profit) of £12151 was achieved. The balance sheet remains strong at £140k of which £121k is in cash. With the extremely low interest rates experienced up to recent times this has not been invested but this is being reviewed with the intention of investing funds for a better return.

It was proposed that the Treasurer's Report and Accounts for the year ending 31 March 2023 be accepted and approved.

- iii) A PIMS member asked if anything could be done about the condition of the drive Mr Youngs advised that the farm lorries impact on the condition of the drive but that it belongs to Hawkins Farm and is not part of our Lease with the National Trust who have, in the past, paid for the repair material, but may not do so in future.

Mr Farrar advised that we do have the necessary equipment and could improve the drive with more regular maintenance.

It was agreed that maintenance of the drive would be considered by the Executive Committee.

Publicity

A special toast must go to Michelle who keeps us in view on Facebook – many people think social media is the way to go, in the long term. This season, I must admit that I haven't got round to giving us a plug on locally available 'events' web sites and no one else has got round to carrying out visitor surveys to find out how they found out we were open. Usually, the results show that good road signs are the most effective. Unfortunately for us, they are the most laborious.

What we have to appreciate is that our job is split neatly into two:

- Firstly, we have to publicise what we are and what they will discover during a visit and
- Secondly, when we are open for visits.

I think overall that we are doing OK, but a little more effort from everyone (including me) would make all the difference.
